- *Blood tests:* from Monday to Saturday from 7:30 a.m. to 10:00 a.m. For the blood tests the Patient can come, without any reservation, fast, provided by the medical prescription.
- delivery of the biological samples: from 7,30 a.m. to 12,00 a.m.

Reports

It is possible to withdraw the medical reports provided of the receipt or of the bill: from Fridav 10,00 19,00 Monday to from a.m. to p.m. ; the Saturday from the 10,00 a.m. to 12,00 a.m. It's possible to delegate a person provided by a document and by the receipt delivered by the personnel during the acceptance. The report will be delivered according to the indications of the European Rule 679/2016 for the guardianship of the privacy.

Upon written request, the medical reports can be emailed.

Upon request, the Direction is available to of the Doctor to discuss the results of the examinations. In case of urgency, the report is delivered with the maximum promptness, allowed by the necessary technical times. Upon request it is possible to telephonely receive the results related to INR, Beta HCG, after compilation and delivery of the special form "Telephone Delegation"

Regional Health Service

The Services of Laboratory Analysis is provided both privately and by accreditation with the Regional Health Service. In order to have the exams with convention, during the acceptance, the Patient must have: the prescription correctly compiled in every field of competence by the Doctor

-The sanitary card

-The fiscal code

Where provided, the Doctor must handle in the special field the code of exemption.

Attention

In every prescription can be demanded no more than 8 examinations. If among the demanded examinations some are exempt from the payment of the ticket, these must be demanded on different prescriptions, for the performances submitted to the payment of the ticket, the other for the exempt performances from the ticket. The Doctor must transcribe on the prescription:

- name last name age of the Patient
- fiscal code
- possible code of exemption
- examinations requested (pointing out " suggested" in case of specialisti prescription)
- date stamp and signature of the Doctor.

The table of charges applied to the Patients with exemption it is equal to that of the National Health Service named Ticket.

The payment of the ticket and the specialistic performances must be effected before the execution of the performances near the Front Desk.

The citizens without exemption are kept to the payment of the performances according to the rates in force, up to the competition of the anticipated import from the normative in action.

The amount of the performances can be also paid with ATM or Credit card.

For performances of Laboratory, near the Front Desk, is available the relative table of charges.

- The amount due to title of ticket and/or for examinations not disbursed by the Regional Health Service, therefore definable as "private", will be quantified and communicated by the personnel of the Reception office during the reservation.
